1. Summary of our assessment

We have assessed that:

- Our 'Specialist' product range continues to meet the needs, characteristics, and objectives of customers in the identified target market.
- The intended distribution strategy remains appropriate for the target market.
- The Product provides fair value to customers in the target market (i.e., the total benefits are proportionate to total costs).

2. Product characteristics & benefits

The products are designed to meet the needs of the target group, applicants wishing to purchase a home for them to reside in either as a new purchase (including first time buyers) or applicants wishing to remortgage. The product features and criteria are designed to support these needs.

- Applicants with multiple layers/complexities to their situation requiring manual underwriting to meet their individual circumstances. Most commonly, the case details will need to be presented to the Society's Mortgage Referrals Committee to approve the mortgage prior to the application being submitted. The committee will consider a range of unusual circumstances due to their combined expertise and ability to assess the risks of the application. The product is not marketed at a specific group of people due to the breadth of the circumstances which will be considered.
- Variable rates of interest
- Interest is calculated on a daily basis
- Variable rates have a floor
- Can be set up as a joint borrower/sole proprietor ownership arrangement

- Can be set up with a tailored term (split term) where the advance has two different term lengths, to support affordability
- Overpayment allowance of 10% of the prevailing balance per annum
- Free valuation where the property value is £1 million or below, or a subsidised fee above £1m
- Product is portable
- Available on interest only up to 70% LTV where the repayment vehicle is sale of another property, or 60% LTV if the repayment vehicle is sale of the applicants' provided downsizing is credible in the area.
- £250 cashback for remortgage applications where the Fastrack remortgage service is not used.

The Product is not designed for customers who:

- Want to fix their interest rate for payment security
- Have borrowing requirements which meet our standard or niche product criteria
- Do not intend to live in the property
- Wish to purchase or remortgage a property outside of England or Wales
- Do not or will not have buildings insurance in place from time of completion
- Wish to borrow all or part of the loan on an interest only basis, but wish to repay the borrowing utilising a repayment strategy which is not selling the mortgaged property or another property they own

4. Customers with characteristics of vulnerability

The Product is designed for house purchase and remortgage customers who meet our standard criteria, this group are not more likely to experience any vulnerabilities, but all customers may experience vulnerability over time where an unanticipated life event occurs.

We considered the needs, characteristics, and objectives of customers with characteristics of vulnerability at all stages of the design process for this Product to ensure the Product meets their needs.
